Public Hearing and Police Committee Meeting March 25, 2021 6:15pm

The Board of Trustees of the Village of Greenwich held a Public Hearing on the proposed Amendment of Local Law #2 of the Year 2008 at 6:15pm and a Special Meeting at 6:30 for the purpose of discussing the Police Reform Collaborative Recommendations. The meeting was held virtually via Zoom. Present were Mayor Fuller, Attorney Kelly, Sargent Danko, Trustees Brown, Robinson, Vandewater and Tefft (both joining at 6:30.)

Mayor Fuller opened the Public Meeting at 6:15pm.

6:15 pm Public Hearing – Local Law #1 of 2021 - AMENDMENT OF VILLAGE OF GREENWICH LOCAL LAW NO. 2 OF THE YEAR 2008, ESTABLISHING RATES AND REGULATIONS FOR WATER SERVICES, CONSTRUCTION AND MAINTENANCE. No members of the public had comment. Tabled until 6:30pm.

Resolution No11 of 2021 – Vehicle Acceptance Statement Typhoon E-One Fire Truck – needed for USDA loan closing. Made on a motion by Trustee Brown, seconded by Trustee Robinson and carried by all.

Voucher #416 – Slide pole replacement - Youth Contractual - \$245.00. Trustee Robinson made a motion to approve, seconded by Trustee Brown and carried by all.

Tax Cap Override discussion. Trustee Brown stated that since the future is unpredictable, there is no harm in passing it. This will be brought before the public at a hearing on April 12th.

Emergency number for National Grid needs to be provided per the contract. This was discussed with an answer to be decided.

6:30 pm Resolution No10 of 2021 – Local Law #1 of 2021 - Amendment of Village of Greenwich Local Law No.2 of the Year 2008. No member of the public commented. Mayor Fuller asked for a motion to approve this resolution, which was made by Trustee Brown, seconded by Trustee Tefft and carried by all.

Police Reform and Reinvention Committee Recommendations

Mayor Fuller asked the Board for comments.

- Changes- 3rd page; Officer Accountability The Village will summarize the formal complaint and state the process used for investigating the complaint. This will be posted on the website. This process will be sent out to anyone who lodges a complaint.
- Also, on page 3, third bullet. Officers on *routine* duty will wear functioning body cameras.
- Page 3, fourth bullet; Trends. In order to monitor trends within the Police Department, the Chief
 Officer will collect and analyze data collected locally and by NYS Unified Court System as part of the
 Police Statistic and Transparency Act as available. Officers on routine duty will wear a functioning
 body camera when available.
- Delete "professional behavior" bullet.

Committee Recommendation Report with changes adopted on a motion by Trustee Brown, seconded by Trustee Robinson and carried by all.
