## VILLAGE OF GREENWICH VEHICLE AND TRAFFIC REGULATION NUMBER 11

### SECTION 1

#### ENABLING LEGISLATION & TITLE

This regulation is adopted pursuant to Section 1640(a)(5) and (16) of the New York State Vehicle & Traffic Law, Section 10(1)(i) of the New York State Municipal Home Rule Law and Section 20-2002 of the New York State Village Law, and shall be known as Vehicle & Traffic Regulation Number 11 of the Village of Greenwich. This regulation may be cited as “VOG VTL 11.” This regulation repeals and replaces any prior Village of Greenwich Ordinances or regulations related to weight limits for motor vehicles operating on Hill Street in the Village of Greenwich.

### SECTION 2

#### HILL STREET WEIGHT LIMIT REGULATION

- 2.1 Motor vehicles having a Gross Vehicle Weight Rating of Five Thousand (5,000) pounds or more are hereby prohibited from traveling on Hill Street in the Village of Greenwich. This regulation shall not apply to police, fire, ambulance or other emergency vehicles or to commercial vehicles making deliveries, pick-ups or service calls on Hill Street. Any violation of this regulation shall be punishable by a fine of \$150.00.

### SECTION 3

#### POSTING OF REGULATIONS

The Superintendent of Public Works of the Village of Greenwich is hereby directed to obtain official signs conforming to the Uniform Traffic Control Device Manual and the Regulations of the New York State Department of Transportation, and to post said signs

at such places upon or along the streets of the Village of Greenwich as may be necessary to advise motorists of the Regulations herein above enacted.

#### **SECTION 4**

#### **EFFECTIVE DATE**

These Regulations shall take effect on the date that signs have been posted or written authorization for providing notice by publication has been received in accordance with Section 3 of this Regulation, except that with respect to State Highways within the Village, this Regulation shall not take effect until written approval from the New York State Department of Transportation has been obtained.

**VILLAGE OF GREENWICH  
VEHICLE AND TRAFFIC REGULATION NUMBER 12**

**SECTION 1**

ENABLING LEGISLATION & TITLE

This regulation is adopted pursuant to Section 6 of Village law Number 1 of 2002 and Section 1643 of the New York State Vehicle & Traffic law and Section 20-2002 of the New York State Village Law, and shall be known as Vehicle & Traffic Regulation Number 12 of the Village of Greenwich. This regulation may be cited as "VOG VTL 12."

**SECTION 2**

SPEED REGULATION

No person shall operate a motor vehicle or motorcycle upon Gray Avenue in the Village of Greenwich at a rate of speed in excess of Twenty-Five (25) miles per hour. This regulation shall not apply to that portion of Gray Avenue that is within the School Zone, which has a speed limit of fifteen (15) miles per hour. This regulation shall not apply to ambulances, fire vehicles or police vehicles when on emergency trips. Any person violating this regulation shall upon conviction be subject to the fines and imprisonment set forth in New York State Vehicle and Traffic Law § 1180(h)(1), as from time to time amended or any successor statute.

**SECTION 3**

POSTING OF REGULATIONS


The Superintendent of Public Works of the Village of Greenwich is hereby directed to obtain official signs conforming to the Uniform Traffic Control Device Manual and the Regulations of the New York State Department of Transportation, and to post said signs at such places upon or along the streets of the Village of Greenwich as may be necessary to advise motorists of the Regulation herein above enacted.

**SECTION 4**

EFFECTIVE DATE

These Regulations shall take effect on the date that signs have been posted in accordance with Section 3 of this Regulation.
